Contractors desiring a hardcopy of the complete bidding documents may obtain them from the office of the City Clerk, Eagan, MN upon payment of \$50.00. No money will be refunded to any person who obtains plans and specifications.

Best Value Contracting Selection: This project is extensive, involving many affected property owners. Timing of the project is critical for the safety of the general public and to minimize disruption. In addition, the City has limited financial resources to commit to the project. Accordingly, the project must be accomplished with a minimum of interruption, on time, and without cost overruns. The City believes that only a contractor with good experience in constructing this kind of project is necessary.

Two factors will be considered in the contractor selection process: price and performance. The process for the consideration of proposals for the award of this Project will take into account not only the Contract amount bid for construction items, but also the bidder's ability and performance on previous similar projects, within and outside the City of Eagan, and the bidder's availability of major equipment to perform this project. A Technical Proposal must be submitted by each prospective bidder so the Contractor's performance can be evaluated prior to the submission of a bid.

Mandatory Pre-Bid Meeting: A Mandatory Pre-Bid meeting will **NOT** be held this year. Any significant changes in the specifications compared to last year will be emailed to all plan holders at least one week prior to the bid.

Technical Proposal Deadline: **Prospective Bidders' technical proposals must be received by 10:30 a.m. C.D.S.T., Thursday, March 23, 2023**, at the Engineering Division (1st Floor), Eagan Municipal Center, 3830 Pilot Knob Road, or emailed to anelson@cityofeagan.com.

Each bid proposal shall be accompanied by a bidder's bond naming the City of Eagan as obligee, a certified check payable to the Clerk of the City of Eagan or a cash deposit equal to at least five percent (5%) of the amount of the bid, which shall be forfeited to the City in the event that the bidder fails to enter into a contract. The City Council reserves the right to retain the deposits of the three lowest bidders for a period not to exceed forty-five (45) days after the date and time set for the opening of the bids. No bids may be withdrawn for a period of forty-five (45)

days after the date and time set for the opening of bids. Payment for the work will be by cash or check.

The City reserves the right to reject any and all bids and technical proposals, to waive irregularities and informalities therein and further reserves the right to award the contract to the best interests of the City.
